INVITATION TO BID

1. The DepEd, Schools Division of Ilocos Sur, Zone V, Bantay, Ilocos Sur through the General Appropriations Act (GAA) under the 2020 Basic Educational Facilities Fund (BEFF) intends to apply the sum of **Eight Million One Hundred Fifty Eight Thousand Six Hundred Eighty Two Pesos & 33/100 (P8,158,682.33)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **CY 2020 BASIC EDUCATIONAL FACILITIES FUND (BEFF) ELECTRIFICATION OF UN-ENERGIZED SCHOOLS AND MODERNIZATION OF ELECTRICAL SYSTEMS ON-GRID SCHOOLS.** Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The DepEd, Schools Division of Ilocos Sur now invites bids for **CY 2020 BASIC EDUCATIONAL FACILITIES FUND (BEFF) ELECTRIFICATION OF UN-ENERGIZED SCHOOLS AND MODERNIZATION OF ELECTRICAL SYSTEMS ON-GRID SCHOOLS.** Completion of the Works for the school, is stated above. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Department of Education, School Division of Ilocos Sur and inspect the Bidding Documents at the address given below from 8:00 o'clock in the morning to 5:00 o'clock in the afternoon.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 17 – February 5, 2020 (5:00 P.M.)** from the address below upon accomplishing a bidder's information sheet and payment in cash of a non-refundable fee by interested bidders of **One Thousand Pesos (Php1,000.00)** for an Approved Budget for the Contract (ABC) per lot of more than Five Hundred Thousand Pesos (Php500,000.00) up to One Million Pesos (Php1,000,000.00) and **Five Thousand Pesos (Php5,000.00)** for an Approved Budget for the Contract (ABC) per lot of more than One Million Pesos (Php1,000,000.00) up to Five Million Pesos (Php 5,000,000.00) to the DepEd, Schools Division Office Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The Department of Education, Schools Division of Ilocos Sur will hold a Pre-Bid Conference on **January 27, 2020, 2:00 P.M.** at Schools Division Office Conference Hall, Zone V, Bantay, Ilocos Sur for Pre-Bid Conference, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 7, 2020, 8:30 A.M.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **February 7, 2020, 9:01 A.M.** at DepEd SDO Ilocos Sur Conference Hall, Zone V, Bantay, Ilocos Sur 2727. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The DepEd, Schools Division of Ilocos Sur reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
