



Once again, the Civil Service Commission will be conducting the Career Service Examination – Pen and Paper Test (CSE-PPT), to be held on March 17, 2019 at Ilocos Sur National High School, Vigan City.

A total of Two Thousand Four Hundred Twenty Nine (2,429) examinees will take the examination composed of Two Thousand One Hundred Five (2,105) examinees for the Professional level and Three Hundred Twenty Four (324) examinees for the Subprofessional level.
