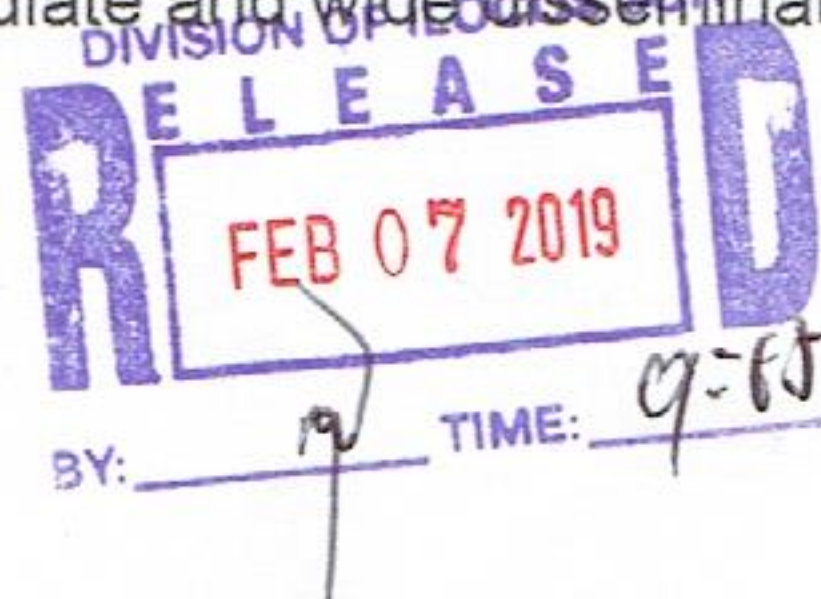

1. Pursuant to DepEd Memo 6, s. 2019 dated January 31, 2019, the Accreditation & Equivalency Test shall be administered in (4) four venues (Please see attached testing Centers) on **February 24, 2019** starting at 7:30 AM.

2. The test shall be administered by the division testing staff which shall be composed of the Division Testing Coordinator as the chief examiner and Education Program Supervisors and School Heads as room supervisors and room examiners.
3. All testing personnel and teacher-applicants must be at the Testing Center at 7:00 AM to give them enough time to look for their room assignment. A & E Test applicants shall bring lead pencil No. 2 and scratch papers for computation purposes. **Examinees must bring a valid ID.**
4. The lists of examinees per room and by session shall be posted later. A copy of the list of examinees shall also be posted in the testing room.
5. Orientation on the conduct of the test shall be conducted by the BEA representative at 1:30 AM at Bantay National High School, Bantay, Ilocos Sur. Members of the Testing Staff shall be given **one day service credit for the administration and one day for the orientation or CTO.**
