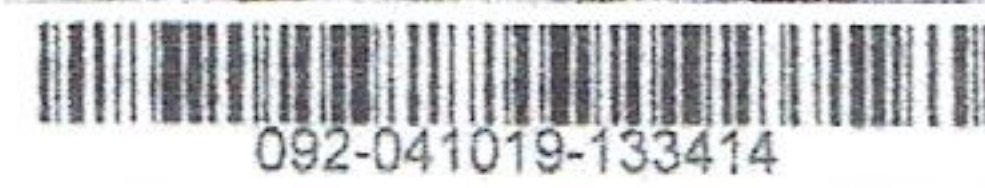


May we also request that if this request is favorably considered, the concerned regional officers and staff as well as the officials of the division offices could be encouraged to attend.
