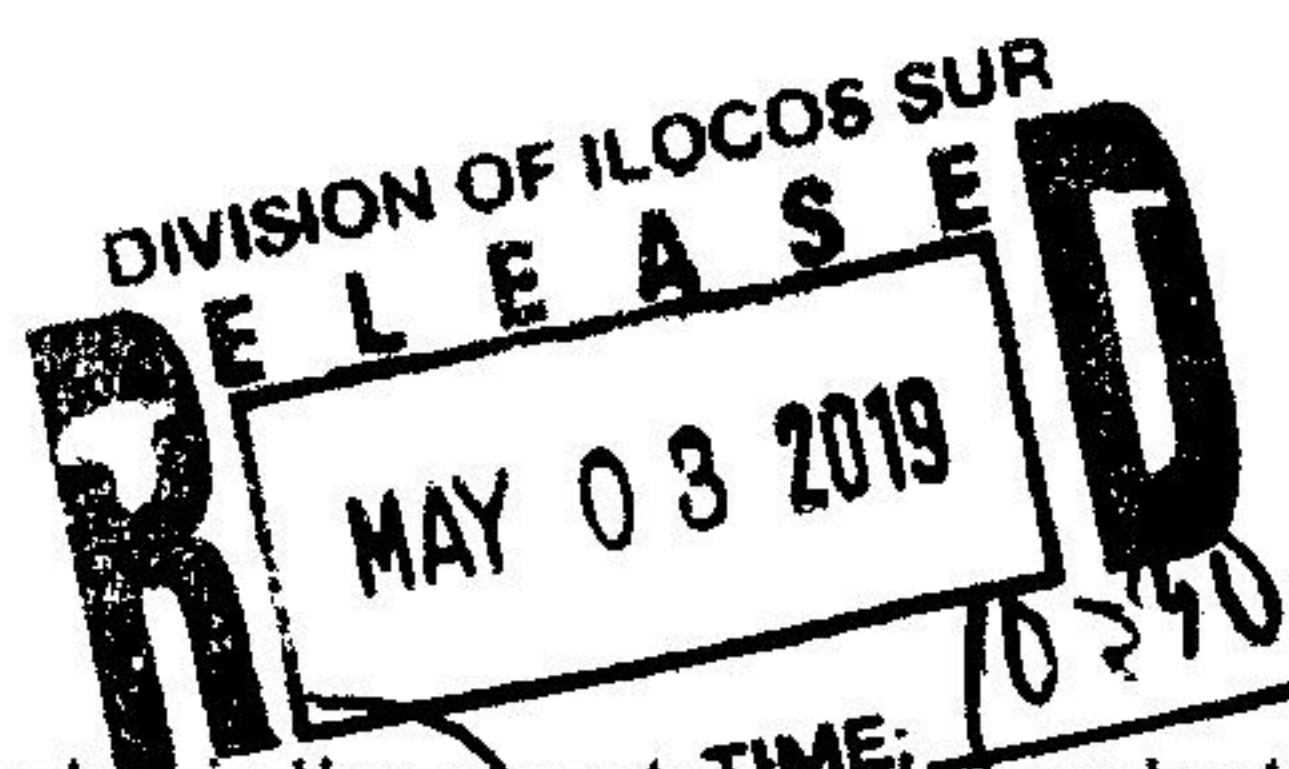

PEPT Applicants

1. Pursuant to DepEd Order No. 55, s. 2016 and DepEd Memo No. 48, s. 2019, the 2019 Regular Philippine Educational Placement Test shall be administered at Bantay National School, Bantay, Ilocos Sur on **June 9, 2019 (Sunday)**. A copy of the application form is attached. This form is **FREE** and can be reproduced. All duly accomplished Registration form shall be submitted to the office on or before **May 24, 2019**.
2. It is advised that all applicants shall be at the Testing Center on or before 7:00 in the morning. They are requested to bring their school Identification, pencils No. 2, snacks and lunch especially those who will take the test for 2 sessions.
3. Prior to the administration of the test, a Division PEPT Orientation shall be conducted on June 9, 2019 at 6:30 AM o'clock at Bantay National School, Bantay, Ilocos Sur.
4. On the examination day, it is also advised that members of the Testing Staff (Please see attached list.) shall be at the Testing Center on or before 6:30 AM. The members of the Testing Staff are in the attached list.
5. School personnel who shall administer the said test shall be given **one day service credit as per DepEd Order No. 53, s. 2003**. For non-teaching personnel, **one day compensatory time off** shall be given.
