SCHOOL-BASED FEEDING PROGRAM (SBFP) IMPLEMENTATION SCHOOL YEAR
2019-2020

1. In reference with Unnumbered Regional Memorandum dated June 4, 2019 re: School-Based Feeding Program (SBFP) Implementation School Year 2019-2020, all Elementary Public Schools are directed of the following policies and guidelines.
2. The Mapping of Schools for the School-Based Feeding Program (SBFP) SY 2019-2020 and the National Weighing of Kinder to Grade 6 learners shall be June prior to the implementation of the said program.
3. It is advised that a calibrated functional weighing scale or preferably beam balance scale shall be used to take the weight and steel tape or microtoise for the height for accurate data gathering. The Body Mass Index (BMI) software shall be used to facilitate the computation of the nutritional status of school children.
4. Ensure 100% deworming of target beneficiaries prior to feeding activity.
5. Conduct group daily handwashing and toothbrushing activities as stipulated in DO no. 10, s.2016 to impart development of positive health promoting values and behaviors.
6. Encourage Gulayan sa Paaralan Program and backyard vegetable gardening to augment the feeding program and to complement the nutrition and poverty reduction initiatives of the Government.
7. For Fiscal Year 2019, SBFP covers all undernourished Kindergarten to Grade 6 learners for 120 feeding days. Feeding shall commence as soon as preparatory activities shall have been conducted and funds are received by the schools to complete the feeding cycle at the end of December, 2019. Feeding activities shall start not later than July 15, 2019. Funds for the Fiscal year shall be utilized within the year.

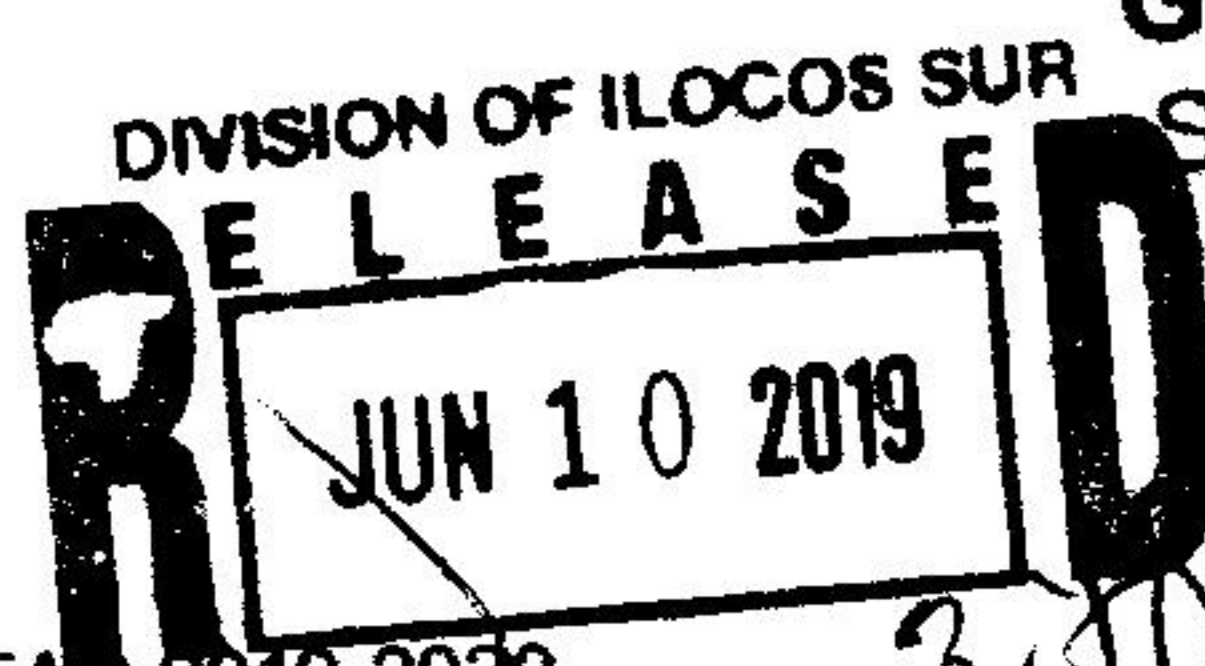
