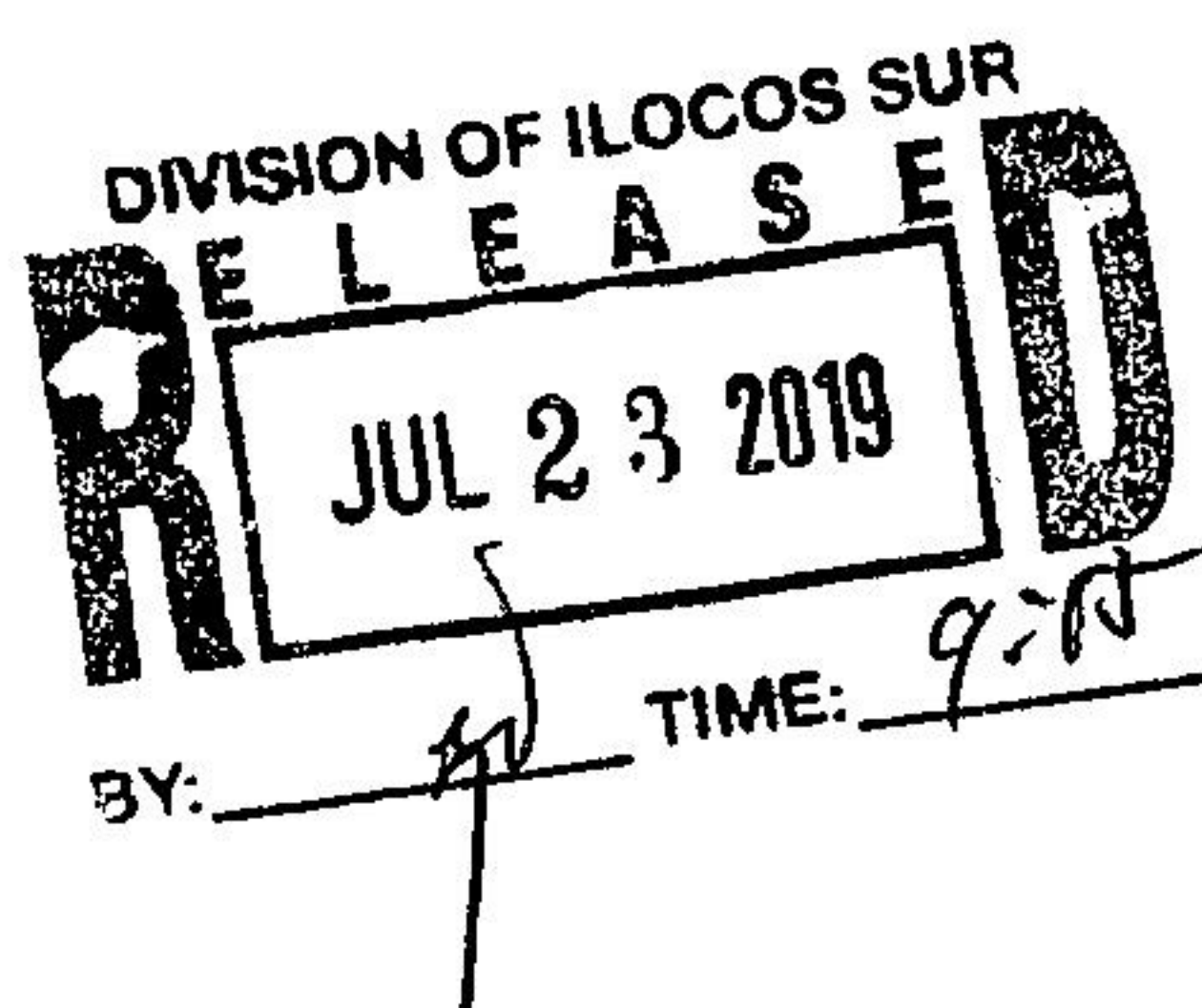

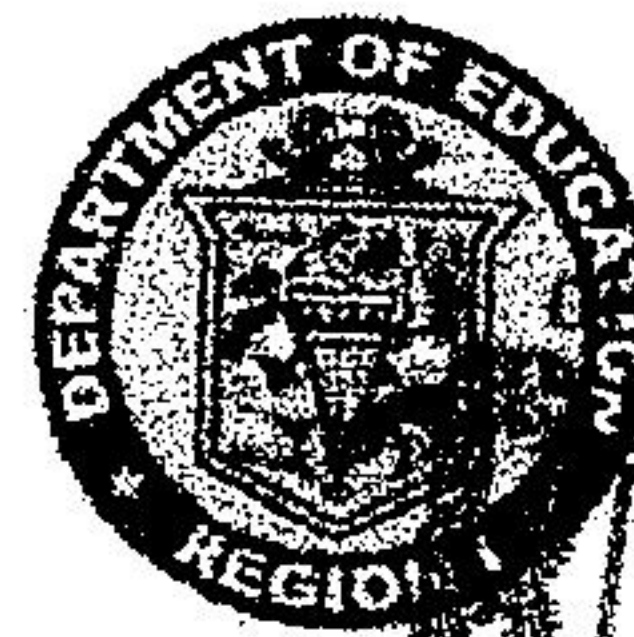

Respectfully returned to the Schools Division Superintendent, Schools Division Office of Ilocos Sur, Bantay, Ilocos Sur, the herein approved request of Mrs. Esmeralda S. Gaburno, Principal I, Comillas North Elementary School, Cervantes, Ilocos Sur, for the conversion of Comillas North Elementary School to Comillas North Integrated School (CNIS) effective School Year 2019-2020 for having satisfactorily met the requirements stipulated in DepEd Order No. 40, s. 2014 (Establishment, Merging, Conversion, and Naming/Renaming of Public Schools, and Separation of Public School Annexes in Basic Education).

It is advised that the local government unit of the Municipality of Cervantes, Ilocos Sur, shall continue to provide financial assistance necessary for the efficient operation of the school to include procurement of instructional materials; construction of additional school buildings; acquisition of school expansion site; and shall continue its support until such time that the national government allocation shall have been provided for the purpose.

It is requested that the school shall be given priority in the deployment of excess teachers in the division. It is also advised that the status of teachers shall be subject to the conditions prescribed in Memorandum OR-GO2016_GOA-0700 (Reiterating the Directive to Discontinue the Hiring of Teachers Using LGU/LSB Funds) issued by Assistant Secretary Jesus Mateo on June 14, 2016.

Training programs for the teachers should be conducted to enable Grade 7 and subsequent teachers to be fully equipped to handle classes per K to 12 guidelines specifically Grade 7 onwards.
