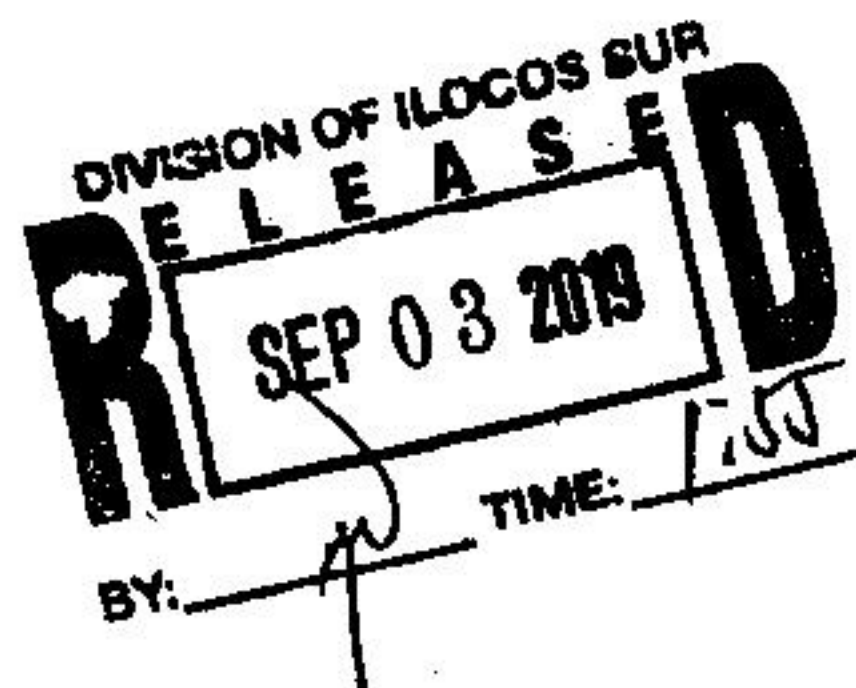

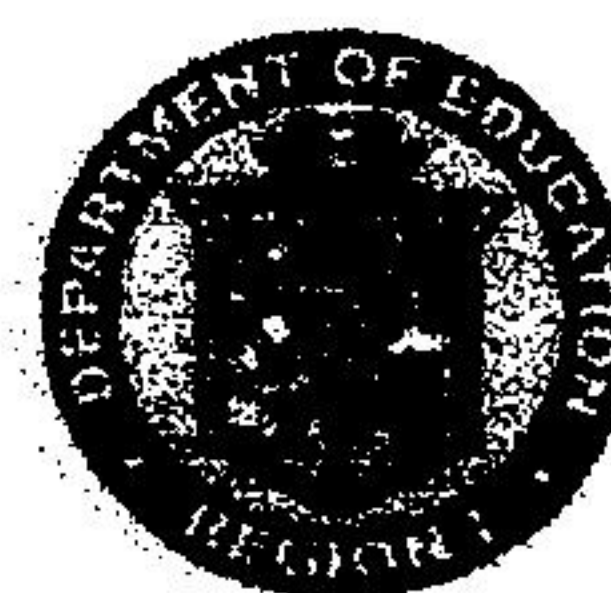

1. Per DepEd Memorandum No. 090, s. 2019, the Department of Education (DepEd) through the Bureau of Learning Resources announces the 3rd National Competition on Storybook Writing.
2. The competition aims to:
 - a. select and award the best storybooks originally developed by teachers for Kindergarten to Grade 3;
 - b. recognize the skills and competencies of teachers in writing and illustrating stories for children, and
 - c. collect storybooks for uploading in the Learning Resources Portal
3. The competition is open to all DepEd school teachers with permanent status. Please refer to the minimum qualifications outlined in the DepEd Memo. cited above.
4. The mechanics and guidelines for the competition including the documents required are provided in the abovementioned memorandum. These shall be strictly followed.
