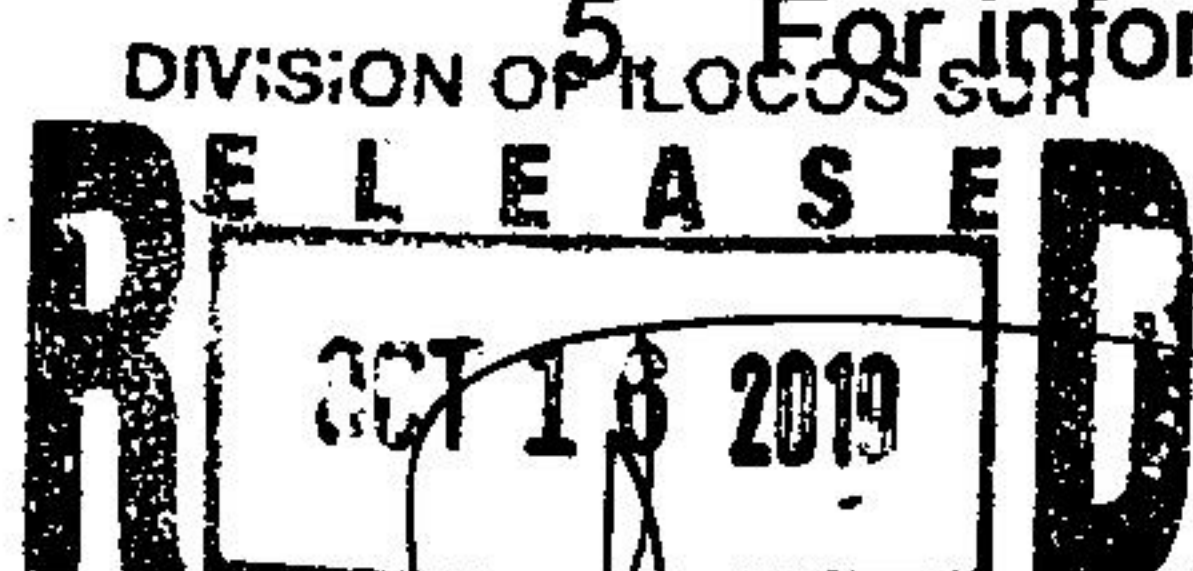
**SUBMISSION OF ENTRIES TO THE 2019 DIVISION SCIENCE AND
