

- 1. Pursuant to DepEd Regional Memorandum No 311 s. 2019, the 2019 Regional Schools Press Conference (RSPC) of DepEd Region I with the theme Empowering Communities through Campus Journalism will be conducted at Tayug National High School, Tayug, Pangasinan on November 7-8, 2019. (Please see Regional Memorandum No. 311 s. 2019 for more details)
- 2. The participants to this activity are the SDO Officials, Division Education Program Supervisors In-Charge of Campus Journalism, Working Committees and the selected (Campus Journalists and SPA-Coaches) in the 2019 Division Schools Press Conference held at Bantay National High School and Bulag Elementary School, Bantay, Ilocos Sur on October 7-9, 2019 from both elementary and secondary levels of the public and private schools in the Division of Ilocos Sur.
- 3. The Regional Schools Press Conference (RSPC) management shall not collect any registration fee, however, for the Division to centralize the management of the meals (Breakfast, Lunch Dinner and AM & PM snacks for two days) of the whole delegation, each participant shall pay a mandatory amount of Php 900.00 which will be charged to Division MOOE/Journalism fund for the Education Program Supervisors and School MOOE downloading/Local funds/journalism fund for the School Paper Adviser- & Campus Journalist-participants and the members of the working committees subject to the usual accounting rules and regulations. Deadline is on October 28, 2019. (Attn: SDO llocos Sur Administrative Section/ Cashier Unit.)
- 4. Travel and other incidental expenses shall be charged to Division MOOE/ Local funds/ School MOOE downloading/Local funds/ journalism fund upon submission of requirements and subject to the usual accounting rules and regulations.
- 5. The Panganiban Central School, Tayug II, Pangasinan shall serve as the billeting quarter for SDO- llocos Sur participants.
- 6. Administrative remedies shall be undertaken to the classes left behind by the teacher participants and interventions shall be given to pupil/student-participants to cope up with the lessons missed by them.
 - 7. Enclosed is the list of SDO llocos Sur official participants to the 2019 RSPC.
 - 8. This memorandum serves as Authority to Travel of the participants.



2019 REGIONAL SCHOOLS PRESS CONFERENCE (RSPC)

To: All Schools Division Superintendents

- 1. The Department of Education (DepEd) Regional Office I through the Curriculum and Learning Management Division (CLMD) announces the conduct of the 2019 Regional Schools Press Conference (RSPC) with the theme **Empowering Communities through Campus Journalism**. The RSPC will be conducted from November 7-8, 2019 at Tayug National High School, Tayug, Pangasinan in the Schools Division II of Pangasinan.
 - 2. The conference aims to:
 - demonstrate understanding of the importance of journalism by expressing it through different journalistic endeavors and approaches;
 - sustain advocacy on social consciousness and environmental awareness;
 - c. provide a venue for an enriching learning experience for students interested in Journalism as a career or those who intend to use skill sets learned through campus journalism to give them a better edge in their chosen careers;
 - d. promote responsible journalism and fair and ethical use of social media; and
 - e. enhance journalistic competence through healthy and friendly competitions.
 - 3. The Conference activities shall include the following:
 - a. Individual Contests
 - 1. News Writing
 - ii. Features Writing
 - iii. Editorial Writing
 - iv. Sports Writing
 - v. Copyreading and Headline Writing
 - vi. Science and Technology Writing
 - vii. Photojournalism
 - viii. Editorial Cartooning
 - ix. Column Writing (exhibition only)



c. Group Contests

d. Awarding of Winners in the different categories and of Outstanding School Paper Adviser (SPA) and Campus Journalist (CJ).

- 4. Recognizing and respecting Intellectual Property Rights, the Department adheres to the rule concerning plagiarism. DepEd reiterates its stand to disqualify school papers found to have copied and published texts, graphics and other materials without duly acknowledging their sources. The disqualification covers all sections of the school paper.
- 5. Any form of plagiarism in all competitions as proven by the board of judges shall be ground for disqualification.
- 6. The three (3) winners from each individual event per contest category per medium and the top placers in the group contests shall participate in the conference.
- 7. The top seven winners in all events per contest category per medium shall be recognized, and the points of individual and group contests garnered shall be included in the computation of the overall scores following existing guidelines.
- 8. Column Writing on a third trial run will be conducted as an exhibition of skills both in Filipino and in English both for elementary and secondary levels. The divisions shall determine their three (3) contestants per level and per medium from their official delegations only.

- 9. The top seven winners from the Column Writing Contest shall be recognized but their scores shall not be included in the computation of the overall scores of their divisions.
- 10. All schools' divisions should strictly follow the No School Paper, No Student Contestant Policy.
- 11. Schools that have collected journalism or subscription fees from their learners should submit school paper entries and **not PDF files.**
- 12. Each SDO shall ready Division Identification (ID) Cards following the design sent to the SDO email accounts.
- 13. Schools Division Offices competing to the group events are advised to bring pocket Wifi and needed equipment.
- 14. Each division is expected to submit the required documents using the format provided in the following enclosures:



- 16. The presidents of the Regional Association of School Paper Advisers (Elementary and Secondary) are requested to join the RTWG on October 31, 2019 and November 5-6, 2019 for the onsite validation of the contest venues and billeting areas and the paper evaluation of the contenders for the selection of outstanding School Paper Adviser and Outstanding Campus Journalist.
- 17. There will be no registration fee to be collected for the expenses of the RSPC. However, as annual membership fee of the organization, P30.00 and P60.00 will be collected for the SPJ and SPA, respectively.
- 18. Schools divisions that will request for their participants to be assisted are advised to coordinate with **Renato Umipig** at mobile no. **09192937742.**
- 19. Non-contestants, parents and other school officials who are not part of the official division delegation are required to seek their own accommodation and contact the host schools division for assistance. They can contact Mark R. Martinez through mobile number 09195183623 or email address: markbolder_25@yahoo.com.
- 20. The participants' and RTWG's travel expenses shall be charged to school's Maintenance and/or Other Operating Expenses/local funds/ School Campus Journalism Fund whichever is applicable, subject to the usual accounting and auditing rules and regulations.
- 21. The fund transfer in the amount of Seven Hundred Fifty Eight thousand and One Hundred Fifteen Pesos (P 758,115.00)) shall be downloaded to the host division to cover the cost of the following:
 - trophies, medals, and certificates/token
 - supplies and materials (conference materials)
 - honoraria and transportation of the judges and resource speakers
 - board and lodging of resource speakers of concurrent sessions and judges
 - contests materials, rental of equipment/vehicle, payment for utilities, contingency and other related expenses incurred in the conduct of RSPC.







GENERAL GUIDELINES FOR THE SELECTION OF WINNERS IN THE DIFFERENT INDIVIDUAL WRITING CONTESTS

The competition in the Individual Writing Contest is designed to showcase the competencies of campus journalists, demonstrate their holistic journalistic skills and proficiency through media exposure, immersion and press conferences, and promote free and responsible journalism.

Only learners from schools with school paper (not necessarily following the specifications for school paper contest), both in English and Filipino for the school year and who won the top three spots in each category are allowed to compete in the various individual contests of the RSPC.

The following will be strictly implemented and complied with:

A. General:

- 1. To facilitate proper identification, the participants are required to wear their school uniform with their valid school ID/RSPC IDs especially during the contest proper, except TV and Radio Script Writing and Broadcasting contestants.
- 2. Should there be questions and assistance needed, the participants can only raise their concerns to the assigned proctor and/or examiner. The proctor shall refer them to the RTWG for appropriate response.
- 3. Contestants should not put any identifying mark on the contest entry or answer sheet.
- 4. School paper advisers, teachers, principals, parents or guardians who will be found in and around the contest venue will be grounds for disqualification of their contestants.
- 5. The top seven winners per medium shall be recognized.
- 6. Any violation of the stipulated guidelines will be grounds for disqualification of the participant.
- 7. The decision of the Board of Judges in all aspects of the contest shall be deemed final and irrevocable.

B. Specific:

1. News, Feature, Column and Editorial Writing:






Fact sheets or other sources of information shall be given to the contestants as bases in writing the article.

- 2. Sports Writing:
- a. The RTWG shall orient and provide final instructions to the contestants before the contest proper.
- b. A pre-game conference shall be conducted for the introduction of the players, coaches, and tournament officials.
- c. Contestants shall watch an actual game where they can gather adequate data.
- d. A post-game conference shall be held to further interview officials and athletes after the game.
- 3. Copyreading & Headline Writing:
- a. The contestants shall bring pencil no. 2 for the contest.
- b. The contestants shall use the 2018 Associated Press (AP) editing marks and follow directions given in the contest piece.
- c. The contestants shall provide the best two headlines for the article.
- 4. Editorial Cartooning:
- a. The contestants shall bring pencil no. 2 and RTWG will provide the oslo papers for the contest.
- b. The cartoon must reflect the elements of editorial cartooning.
- c. The cartoon should be, at all times, compliant with the professional and ethical standards of media.
- 5. Science and Technology Writing
 Fact sheets or other sources of information shall be given to the contestants as bases in writing a feature article.
- 6. Photojournalism
- a. Preparation:
- 1) Contestants should be at the contest venue thirty (30) minutes before the orientation on the guidelines and rubrics.
- 2) The contestants are allowed to use any Digital Camera (point and shoot only) with a maximum of 20.1 megapixels with fixed lenses only. Contestants who will use any DSLR and other high-end cameras will **not be permitted to join the contest**.





- 3) The contestants shall format their own memory card and camera to be checked by the examiner/s.
- 4) The contestant should bring his/her own camera cable for saving of pictures.
- 5) Cellular phones, extra digital cameras, extra storage card or any additional materials/equipment are not allowed in the contest area.
- 6) Contestants shall bring their own black ink ballpen while the RTWG will provide scratch papers where contestants can write down notes during the shooting.
- 7) Contestants shall set the date and time of their own camera.
- b. Photo Shoot, Uploading and Captioning
- 1) Control shot shall be the first shot.
- 2) Contestants are given one (1) hour to take pictures, which does not include the loading and unloading of the storage card in front of the examiner on a theme to be provided during the orientation.
- 3) Contestants are allowed to take **unlimited shots** but will submit five (5) possible photos with caption for the given theme and the control shot.
- 4) Contestants shall retain in the memory card photos to be submitted only.
- 5) Contestants will be given 30 minutes to write captions for each of the five photos.
- 6) Caption sheets (with lines and margins) will be provided by the RTWG.
- 7) All entries with caption sheets shall be submitted to the examiner after the allotted time.
- 8) Memory cards per region will be returned to the participants through their Education Program Supervisor in charge of Campus Journalism after the closing program.
- 9) During the duration of the competition, the advisers, trainers, and parents are NOT allowed in the venue.

GENERAL GUIDELINES FOR SCHOOL PAPER CONTESTS

A. The School Paper Contest is open to Elementary and Secondary schools whose school papers belong to the top ten per section per category in the division.


- B. Any school paper found to have copied and published texts, images and other materials without duly acknowledging their sources shall be disqualified in the contest.
- C. If the school paper shall join again the following year and found to have committed the same offense, the following sanctions shall be applied:

1st Offense: A formal notification shall be sent to Schools Division Superintendent who shall inform the concerned School Head/Principal. The SDS shall issue a written reprimand to the school paper adviser/s and the school principal. The concerned school paper adviser shall undergo a refresher course on Plagiarism organized by the Division. The Principal shall be asked to implement plans to teach their students about the ills of plagiarism and its consequences. 2nd Offense: Disqualification from the School Paper Contests for three (3) consecutive years.

- D. The decision of the Board of Judges in all aspects of the contest shall be deemed final and irrevocable.
- E. The school paper shall be submitted in paper-based format only: Each division shall submit ten (10) best entries per category. Schools that will submit entries should include a Certificate of Circulation from the school principal duly noted by the Schools Division Superintendent that the printed school paper was widely circulated to at least two-thirds (2/3) of students' population of the current school year. This certification should be included in the documents submitted to the Regional Office before the regional judging of the school papers.

The Regional Technical Working Group (RTWG) reserves the right to disqualify entries without Certificate of Endorsement from the Schools Division Superintendent.

All entries submitted to the Curriculum and Learning Management Division (CLMD) shall become property of the Department of Education-Regional Office which grants the agency the exclusive right to exercise copyright and other intellectual property rights including storage, exhibition, derivation and distribution.

- 1. News Section / Pahinang Balita
- 2. Editorial Section / Pahinang Editoryal
- 3. Feature Section / Pahinang Lathalain
- 4. Sports Section / Pahinang Pampalakasan
- 5. Science & Technology Section / Pahinang Agham at Teknolohiya
- 6. Layout and Page Design Category / Kategoryang Pag-aanyo at Disenyo ng Pahina
- G. The Technical Specifications for both Elementary and Secondary levels are as follows:
- 1. No. of pages: minimum of 12 and maximum of 20

News Section—at least 3

Sports Section - at least 2

Feature Section - at least 3

Editorial Section - at least 2

Science & Technology Section - at least 2

- 3. Paper stock: Bookpaper or C2S 60GSM 80 GSM
- 4. Color: Front and back cover in full color



- H. Each section will be judged according to the guidelines/criteria set for the section/category.
- I. After a thorough two-day evaluation by a set of judges, each division will submit ten (10) winners per section and for each medium (English and Filipino) to the Regional Office. The school paper entries should be properly sealed and labeled per section.
- J. Sufficient copies of the school paper entries should be included in the package. A list of winning division entries should also accompany the package, which should be duly endorsed by the Schools Division Superintendent to the Curriculum and Learning Management Division on or before the deadline.
- K. Failure to comply with the set guidelines in evaluating school papers will be a ground for disqualification.

Search for the Outstanding Campus Journalists of the Philippines

Guidelines

- Each Regional School Paper Advisers Association and the Regional Editors'
 Guild in cooperation with the Department of Education regional office shall
 select ONE outstanding campus journalist of the region for elementary
 and one for the secondary.
- 2. The panel of judges in the regional search shall be composed of the following:

The CLMD Chief as chair, regional supervisors in-charge of journalism as co-chairs, president of the regional school paper advisers' association both in the elementary and secondary as members.

- 3. The candidate shall attach the photocopy of all documents for the last three years duly certified true and correct by the Division Supervisor in charge of Journalism for verification and evaluation by the regional search committee and endorsed by the Schools Division Superintendent.
- 4. The candidate must be a campus journalist and of good moral character.
- 5. The awardees for the Search for Outstanding Campus Journalist (OSCJ) shall be evaluated on the following criteria:

A. ACADEMIC PERFORMANCE (20%)

(for the past two years up to the 2nd quarter of the current school year)

Rank (in class)

with Highest Honors or its equivalent -20 % with High Honors or its equivalent -15% with Honors or its equivalent -10%

B. ACHIEVEMENTS IN JOURNALISM (45%) (highest possible score: 162+84+66 = 312)

WINNINGS FROM THE NSPC/RSPC/DSPC

The candidate shall earn the corresponding points for every year of winning:

1. Individual Contests (highest possible score – 54x3 = 162)





- 5. The panel of judges shall be: (For the Regional selection) CLMD Chief, Regional DepEd in-charge of journalism and Association President


CHECKLIST FOR THE SEARCH FOR OUTSTANDING SCHOOL PAPER ADVISER


