

#### В. The SDRC will have the following roles and responsibilities:

- Provide directions on research initiatives through the national and local Basic Education Research Agenda, and other identified priority research areas in the division;
- Evaluate and approve research proposals and other related research initiatives from the schools and community learning centers (CLCs) to be funded under BERF;
- Evaluate and approve research proposals and other related research 3. initiatives within the schools division to be funded by other fund sources;
- Forge partnerships with academic and research institutions, government agencies, and other DepEd offices on education research initiatives and projects;
- 5. Prepare and submit reports to the RRC on all research initiatives conducted in the division from all fund sources;
- resolve emerging issues on the management and conduct of research 6.
- Ensure that cost estimates fall under the existing accounting and auditing rules and regulations; and
- Endorse approved school level proposals to the Regional Office for 8. confirmation and release of funds under BERF.

#### The SDRC Secretariat will deliver the following:

- Organize, coordinate, and document meetings of the Committee;
- Conduct initial screening of submitted proposals for compliance with submission guidelines;
- Aid SDRC members in recommending proposals for approval as per the criteria and scoring template provided in Annex 4;
- Liaise with academic and research institutions government agencies, and other DepEd offices in the conduct of the research;
- Provide technical assistance to researchers on the conduct of their studies;
