DIVISION ORIENTATION FOR RATERS ON RESULTS-BASED PERFORMANCE MANAGEMENT SYSTEM (RPMS) - PHILIPPINE PROFESSIONAL STANDARDS FOR TEACHERS (PPST) FOR SCHOOL YEAR 2019-2020

- 1. To ensure the successful implementation of the Results-Based Performance Management System (RPMS) with the Philippine Professional Standards for Teachers (PPST) Performance Cycle for SY 2019-2020, it is essential to reinforce the knowledge and understanding of raters and further capacitate them on the use of and protocols for the different PPST-based RPMS assessment tools for teachers.
