WHEREAS, the Department of Education Division of Aklan advertised/posted the invitation to Bid/ Request for Expression of Interest of the project LEASE OF REAL PROPERTY AND VENUE WITH LODGING AND ACCOMMODATION AND CATERING SERVICES FOR THE CONDUCT OF NATIONAL TRAINING OF SPORTS COACHING FOR ADVANCE LEVEL (CLUSTER II), in the DepED-Division of Aklan website, the PhilGEPS and a conspicuous place at the premises of the Department of Education-Division of Aklan;

WHEREAS, One (1) supplier quotations was submitted and passed the preliminary examination of quotes;

WHEREAS, upon evaluation of the documents submitted by Marzon Hotel Kalibo, it was found out that this bidder has the Red PhilGEPS Registration Certificate;

WHEREAS, Circular 03-2016 issued by the Government Procurement Policy Board, Section 4.1.2 states that "Starting 1 May, 2017, bidders for competitive bidding will be required to submit their PhilGEPS Certificate of Registration of Membership under the Platinum Category during the eligibility check or bid submission, as the case may, in lieu of their Class "A" Documents uploaded and maintained current and updated in the PhilGEPS pursuant to Section 8.5.2 of the 2016 Revised IRR of RA 9184"

WHEREAS, Marzon Hotel Kalibo having the PhilGEPS Certificate of Registration under the Red Category is automatically DISQUALIFIED;

NOW. THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the FAILURE OF BIDDING for the project LEASE OF REAL PROPERTY AND VENUE WITH LODGING AND ACCOMMODATION AND CATERING SERVICES FOR THE CONDUCT OF NATIONAL TRAINING OF SPORTS COACHING

FOR ADVANCE LEVEL (CLUSTER II), to recommend for approval by the Schools Division Superintendent of the Department of Education-Division of Aklan the foregoing findings.
